




- GRAVEL EMBANKMENTS. 5. CONTRACTOR MINE SITE EXECUTION PLAN SHALL ANTICIPATE AND ADDRESS TIMELY IDENTIFICATION AND REMOVAL/DISPOSAL OF INTERBEDDED LAYERS OF DELETERIOUS MATERIAL (SILT/CLAY, etc) WITHIN SAND/GRAVEL LAYERS PRIOR TO HAULING TO THE PROJECT.


- LIFT THICKNESSES WILL VARY DEPENDING UPON LOCATION WITHIN MINE SITE.






